## 6. Case Studies

## Case Study 1 - The Private Studio Rationalisation

## **Background:**

A long-time musician and synthesizer enthusiast had accumulated more than thirty vintage instruments over two decades. With a growing sense of overwhelm and limited space, he sought clarity on what to keep, what to service, and what to release.

## **Our Approach:**

Through an on-site consultation, we catalogued his entire studio, assessing each instrument's condition, originality, and current market relevance. A tiered plan was developed — balancing practical studio use with long-term collection value.

#### **Outcome:**

A structured downsizing was achieved without compromise to the client's creative workflow. Several restored pieces were later sold through RL Music's brokerage network, funding future projects while preserving a curated core collection.

## Case Study 2 – Estate Collection Management

## **Background:**

A family inherited a substantial collection of vintage keyboards and recording equipment following the passing of a relative who had worked in the music industry. The family sought professional assistance to understand its value and decide on its future.

## **Our Approach:**

RL Music conducted a full inventory and valuation, producing documentation suitable for insurance and estate planning. Each item was photographed and assessed for condition and provenance. Sensitive guidance was provided on the most appropriate pathways for sale, donation, or retention.

## Case Study 3 – Institutional Archive Consultation

## **Background:**

A university's music department held a legacy collection of analogue synthesizers and early digital workstations, many of which had fallen into disuse. They sought expertise to catalogue, evaluate, and plan future access to the collection.

## Our Approach:

Working in collaboration with the department's technical staff, RL Music provided a structured audit, identifying pieces suitable for restoration and public display, and others to be deaccessioned through controlled sale.

The resulting archive catalogue supported grant funding for preservation and exhibition, giving students and researchers access to a revitalised piece of electronic music history.

## Case Study 4 - Remote Collection Consultation

## **Background:**

An overseas client, based in France, owned a mixed collection of vintage and modern synthesizers but lacked a clear understanding of their current market position or long-term preservation needs. Travel constraints made an on-site visit impractical.

## Our Approach:

Through a structured remote consultation, supported by photographs, serial records, and live video walkthroughs, RL Music conducted a detailed assessment of the collection. Instruments were categorised by rarity, market demand, and service priority.

#### **Outcome:**

The client received a comprehensive digital catalogue and prioritised maintenance plan, enabling him to make informed decisions about restoration, insurance, and potential future sales.
